

## Titanic Disaster - "4/12"

WASHINGTON, May 1.-The United States delegates to the London wireless conference in June will advance a proposition to lengthen the radio wave in distress communications. This is to be urged as a means of avoiding the confusion that marked the wireless work during the last hours of the Titanio disaster, when 1,600 lives were lost that might have been saved if the wireless communication had been what it should have been.



- Before Disaster:
  - MV Mesaba: ".....saw much heavy pack ice (in your location) and great number of large ice bergs...."
  - RMS Titanic: "......from passenger K. Blowfeld to Uncle Joseph: 'buy low and sell high ...Tell Aunty June that her crystal from Paris is safe' "
  - "Mesaba, keep out, I'm working Cape Race for passenger messages"
- During Disaster:
  - RMS Titanic: Repeated distress signals: "CQD,CQD, SOS, SOS....."
  - MV Frankfurt: "What is the matter with u?..."
  - RMS Titanic: "You fool, stdbi and keep out!...."





Following RFP award, FirstNet will deliver State radio access network (RAN) Plans to each State/Territory

#### Under the Act, the Governor has 90 days to choose whether to

- 1. Participate in the FirstNet proposed RAN deployment or
- 2. Assume responsibility to conduct its own state RAN deployment




